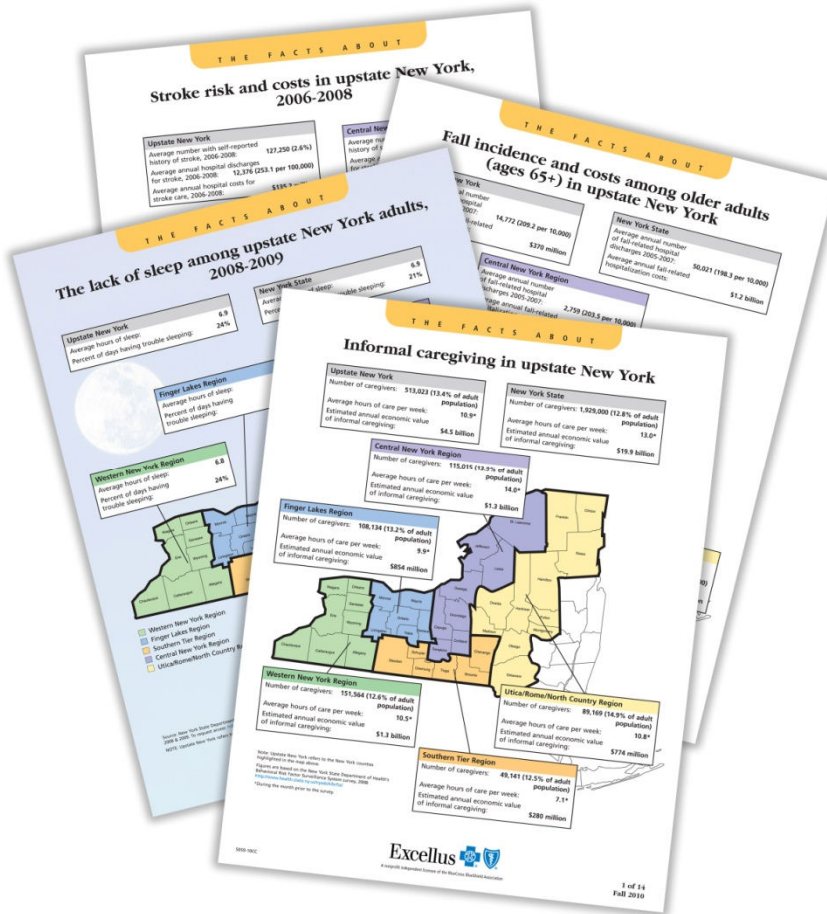


## **Our orientation...**

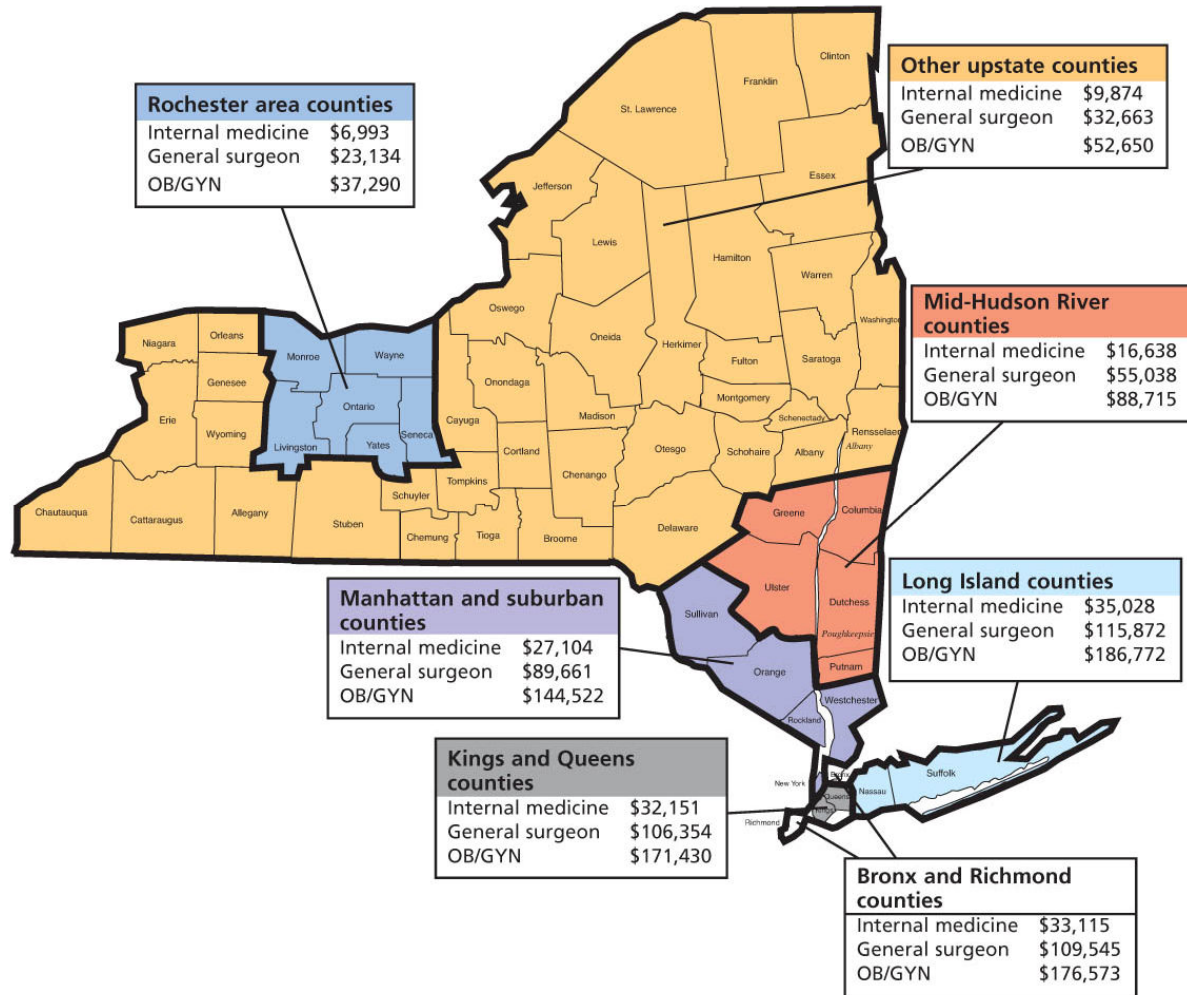


## Medical malpractice was one of those topics

- **Because much attention is focused on the topic of medical malpractice costs, we wanted to know and to share the basics with our communities:**
  1. How much does medical malpractice coverage cost?
  2. Does it vary within the state? If so, by how much?
  3. What does it cost in other states?
  4. Is there a definitive study that shows the cost impact of medical malpractice and defensive medicine?
- **Note of caution: the last time we looked was prior to changes in NYS rates made in August 2011**



# Standard medical malpractice premium rates in NYS (July 2010-June 2011)

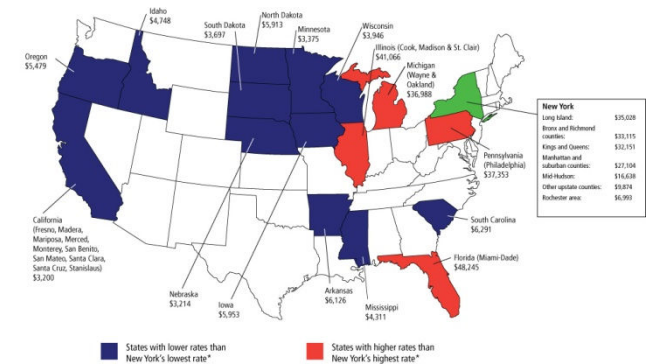


**Variations can be as much as 300% between the lowest-cost region and the highest-cost region.**



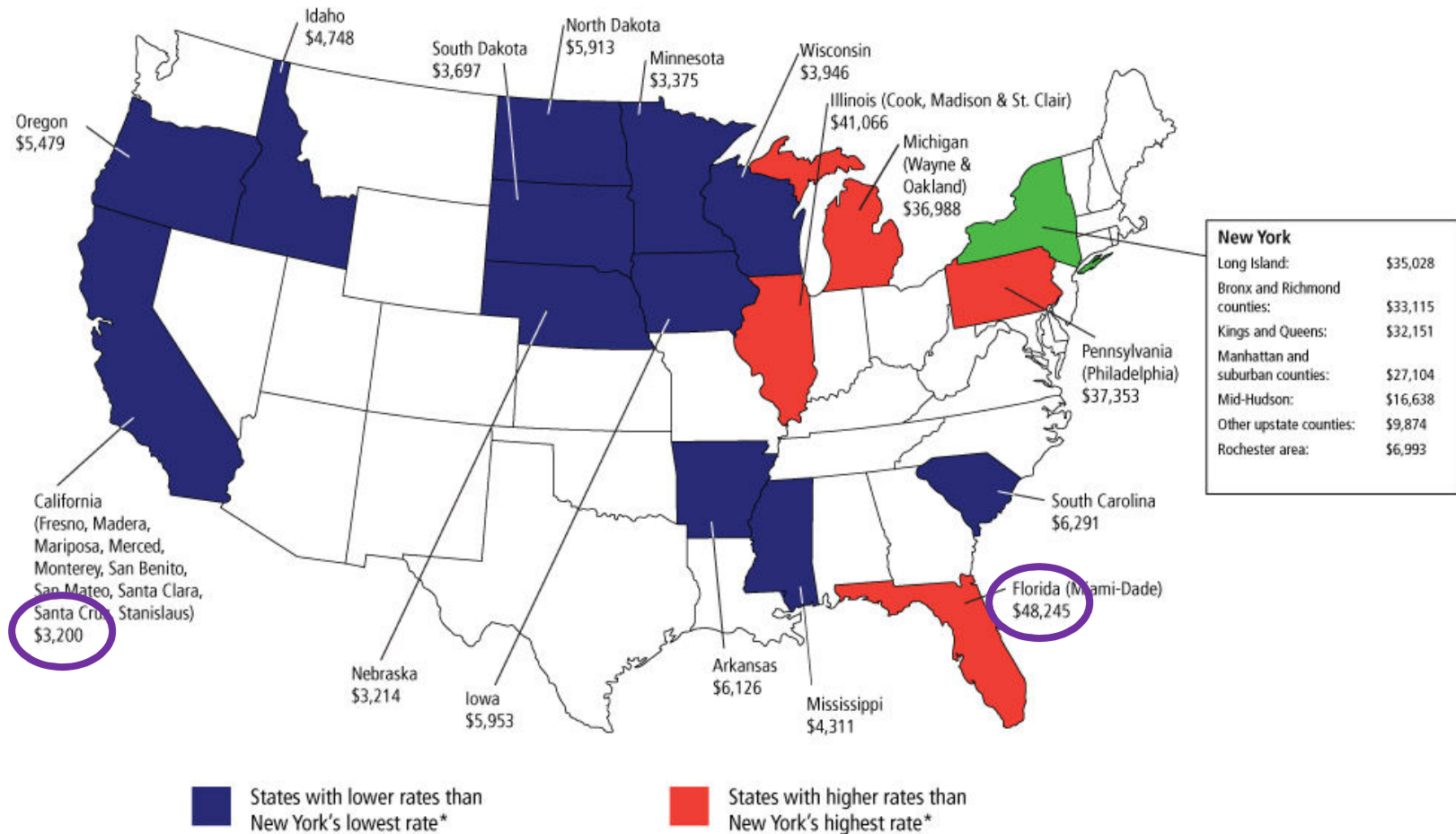
# Getting an idea on medical malpractice coverage premiums paid in other states

- **Next 3 slides look at malpractice premiums for three physician practices across the country, relating them to lowest and highest standard rates in NYS**
- **Samples outside of NYS are based on a review of Medical Liability Monitor survey**
- **Blue means: states where there were rates LOWER than the lowest standard rate in NYS**
- **Red means: states where there were rates HIGHER than the highest standard rate in NYS**



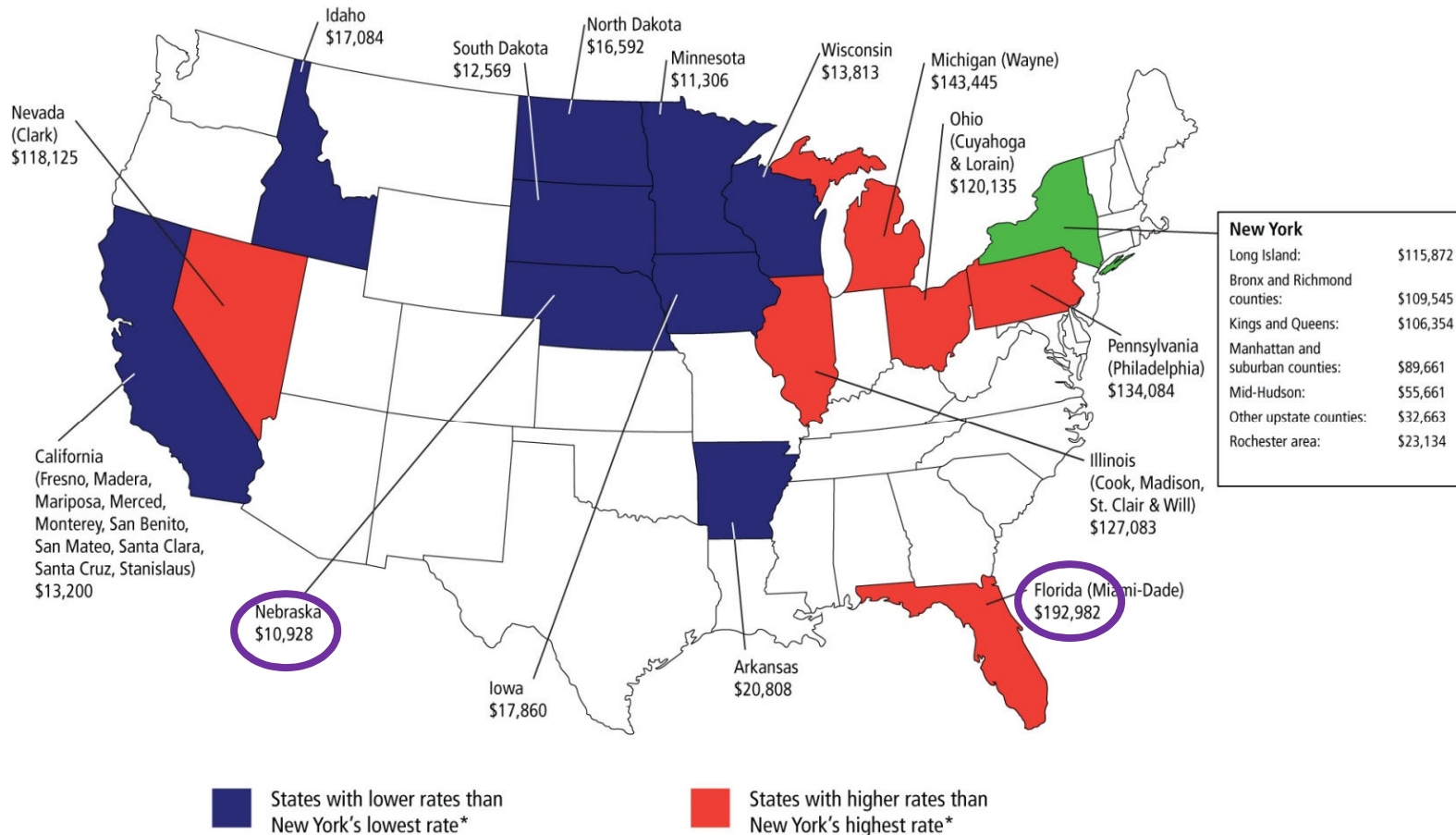


# Internal Medicine - Sample medical malpractice rates, 2010



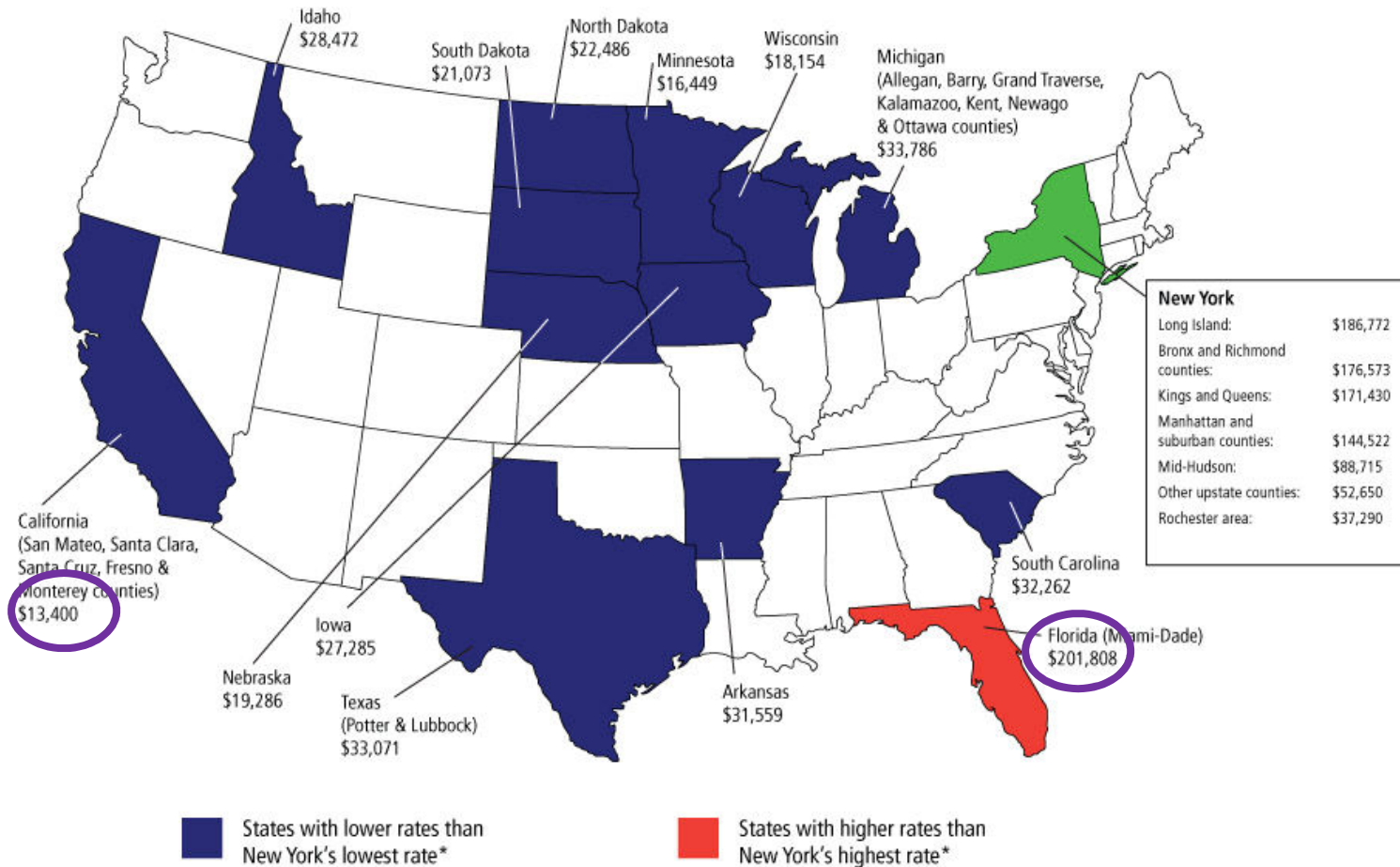


# General Surgery – Sample medical malpractice rates, 2010





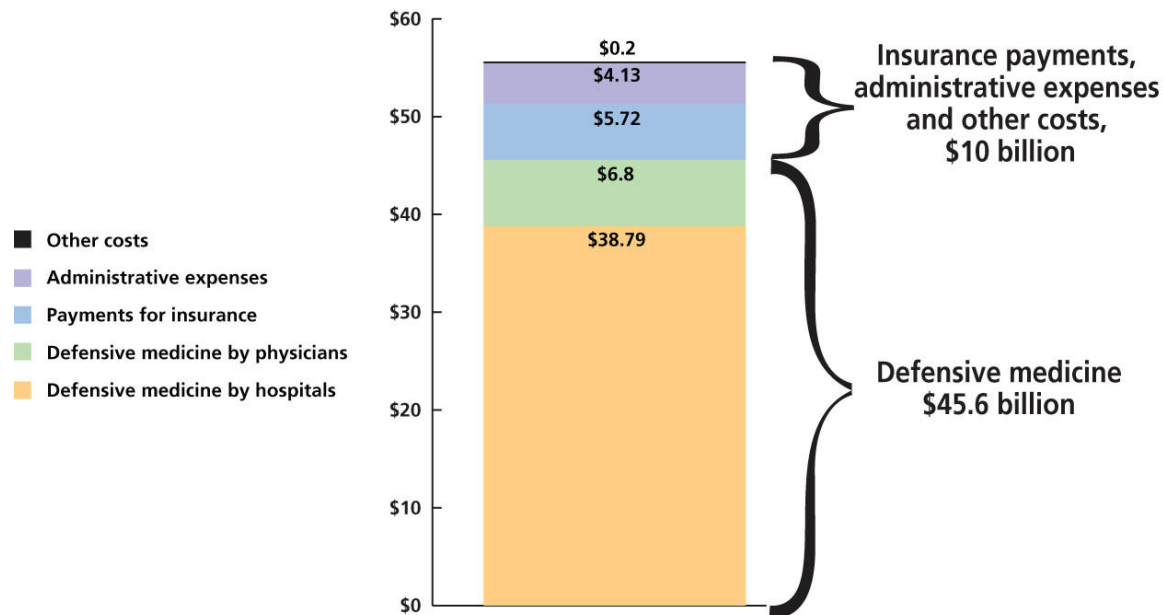
# Obstetrics & Gynecology – Sample medical malpractice rates, 2010
